PROGRAM DESCRIPTION

The following concepts & frameworks pertaining to value investing will be covered over 4 days

- · Generating Ideas
- Analysis from primary sources (Annual Report, Transcripts, Presentations etc.)
- Analysis from secondary sources and basics of due diligence (Industry studies, scuttlebutt and sell side research, judging management quality and pedigree)
- · How not to lose money Financial Shenanigans, Frauds, Corporate Governance etc.
- · Blast from the past role of financial history for current and future generation of investors
- · How to benefit from occasional disconnects in Capital Markets
- Common errors in valuing the business and role of embedded expectations implied by current market prices

The faculty and participants will be analyzing and discussing companies from an investment angle with relation to the topics mentioned. The goal would be to understand the subject matter better through real life examples and cases.

LEARNING METHODOLOGY

Combination of class room lectures, Case studies, assignment and group discussions (mandatory)

WHO SHOULD ATTEND?

The program will be suitable for:

- Candidates with 5 + years of professional research or investing experience.
- Candidates willing to invest time and effort to improve overall experience of the cohort with reasonable level of intensity and commitment.

WHO SHOULD NOT ATTEND?

This program is not suitable for beginners / individuals who are just starting off their investment journey.

It is expected that the participants know the basics of investing. The program is not suitable for you if:

- You do not have working knowledge of financial statement preparation (Balance Sheet, P&L, Cash flow)
- · You do not know basic ratio-analysis
- · You have never read an Annual Report
- · You do not have a basic understanding of research and investing

Applicants should carefully consider the above points before applying for the course.

WHAT TO EXPECT?

- A detailed understanding of various frameworks used in the investment process, with case studies.
- · A spirited discussion on various concepts of investing
- · Techniques of analysis and valuation

WHAT NOT TO EXPECT?

- No 'tips'. Purpose of the program is to understand investing better and become better investors
- The faculty has no expertise in technical analysis, various short-term trading strategies etc. Therefore, these aspects will not be covered.

OTHER INSTRUCTIONS

- Since this is a case-study based approach, it is a must that you bring your own laptop with MS Excel and calculator.
- Please note that active participation of applicants is a must, since case studies will be covered. You will be required to sit and study cases in class, post which there will be discussions on the same.
- Participants will be required to come prepared with given pre-course work.

SELECTION CRITERIA

Candidates who have the aspirations for a successful career in investment management are encouraged to attend. This program is highly recommended for candidates who share our conviction in value investing and behavioral finance. Each applicant will be evaluated on several criteria to ensure that the participants selected for the program are well-rounded individuals with capacities of contributing to classroom participation and peer learning.

Acknowledging that learning also comes from diverse backgrounds, participants will be selected on the following criteria:

- Quantity and quality of work experience
- · Commitment and passion for the field of investing
- Evidence of professional success
- Education qualifications

All applicants to note the following:

- Admission to the program is not subject to early submission of application form and cheque sent.
- Corporate nominations will be restricted to not more than five nominees so as to ensure a fair distribution of the cohort.

PROGRAM FEES

- INR 42,500 plus GST (INR 50,150) which includes tuition, course materials, meals and on campus accommodation.
- Fee does not include travel and other incidental expenses.
- Candidates need to submit the application form online and mail the payment to FLAME. Only cheques will be accepted as a payment method.
- The cheque payment must reach FLAME by the application deadline. Kindly note, even if the application is submitted, but the payment does not reach FLAME by the application deadline, the application will be deemed incomplete and annulled.
- Cheques should be made payable to 'FLAME University'.
- Cheque should be dated May 17, 2024. Candidates should write their name and the program they have applied for behind the cheque.

- · Candidates are requested to use preferred courier services such as Speed Post or Blue Dart.

To apply the applicant must complete the application form.

During the duration of the program, participants are encouraged to explore the campus and use the facilities FLAME offers.


ACCOMMODATION
