38 awards were received for research/ innovations by the institution/ faculty / research scholars/ students.







The Q centre aims to help students to get additional help on quantitative methods that many courses in FLAME cover and to sharpen their quantitative skills. It has designated faculty members along with quantitative instructors and an empaneled team of peer tutors. The activities of the centre shall include study sessions, workshops, one-on-one tutoring sessions, coding competitions, etc.



THE WRITING CENTRE

The Writing Centre offers the student community an arena in which to engage with itself, in intellectually empowering ways. Any student can make an appointment, to discuss a writing assignment with our undergraduate peer tutors. These consultations are holistic, helping students not only to excel in curricular terms, but to take a step forward in their personal intellectual growth.

The case method of teaching has gained popularity in the Education, Law, Medical, Management, Psychology, Sociology, and several other professional disciplines. There are several popular case repositories like HBS Educator, ECCH, Science Case Network, Asian IT Cases Series etc. from where teachers can source teaching cases for their courses. At FLAME University, the case method of teaching is practiced across all its faculties. Now many of the FLAME University faculty members use case method of teaching in their courses and have prior exposure to the craft of case writing and research. FLAME Centre for Case Development (FCCD) intends to become a repository of cases across multiple disciplines by providing necessary infrastructure and encouragement to the FLAME University faculty members for case writing.

The Centre is engaged in the following activities with the involvement of the FLAME University faculty.

- Encouraging case pedagogy and writing of cases by the FLAME University faculty members through conducting case workshops, training the faculty in case teaching and
- case writing.
- Arranging invited talks of renowned experts of case writing & teaching.
- Conducting case conferences at FLAME University.
- Providing FLAME University's financial sponsorship to its faculty members for writing good field based 'teaching cases'.
- Developing linkages with industry to explore the possibilities of writing field-based cases by FLAME University's faculty.
- Encouraging FLAME University's faculty to write cases by giving an annual cash reward to a case which is adjudged as the best case of all the cases written by FLAME University's faculty in a particular year.
- Collaborations with other renowned institutions/organizations to offer joint workshops on case writing and teaching.
- Creating a knowledge repository for material on 'case writing and teaching' in FLAME University's Vivekananda library.

CENTRE FOR SOUTH AND SOUTHEAST ASIA STUDIES

Established in 2018 on the FLAME Campus following an international collaboration model with National Chengchi University of Taiwan, the Centre for South and Southeast Asia Studies (CSSAS) aims to promote the research capacity in political, economic, social, and cultural studies of the Indo-Pacific region. A member of an international network of prominent think tanks in the Asia Pacific, CSSAS FLAME is dedicated to the understanding, collaboration, and connection between research communities, educators, and students within India and across the region. At the same time, CSSAS FLAME serves as a platform for FLAME community members to better interact with their international counterparts of Indo-Pacific countries.

CSSAS FLAME hosts talks, workshops, conferences as well as other forms of scholarly and student exchange activities to promote the Indo-Pacific studies in the context of India's 'Act East Policy.' CSSAS FLAME publishes jointly an online magazine Asia Insight with the Institute of International Relations (IIR) and the Centre for Southeast Asian Studies (CSEAS) of National Chengchi University to routinely provide analysis of international relations and regional dynamics in Asia.

The Centre for Economics and Public Policy (CEPP), FLAME University, Pune, aims to pursue a dynamic agenda at the intersection of Economics and Public Policy through faculty seminars, collaborative grants, white papers, student-led research, invited lectures, workshops, documentary screenings, conferences, and invited expert-authored articles. The Centre aims to become a forum of choice for interactions between students, faculty, state policymakers, researchers, and NGOs to provide rigorous and policy-relevant analysis of contemporary problems.

The following key short-term objectives are sought to be achieved by the deliverables in brackets below:

- Establish links with key stakeholders (workshop)
- Establish durable partnerships with compatible partner organizations (MOU's)
- Contribute to the scholarly discourse at the nexus of economics and public policy (research publications)
- Serve as a forum of choice for outside scholars and scholar-practitioners to dialogue with FLAME faculty and students on relevant issues in economics and public policy (Invited talks)
- Contribute to the media discourse on issues at the intersection of economics and public policy (op-eds)

ACTIVITIES

The academic year 2022-23 was a productive one for the Centre for Economics and Public Policy (CEPP). In addition to organizing talks, the Centre also sought to diversify the range of its activities to include supporting conferences, planning workshops, screening documentaries, supporting book launches and talks by residential scholars at FLAME.

CENTRE FOR MATHEMATICAL MODELLING

The aim of the Centre for Mathematical Modelling (CMM) is to promote teaching and research in applied mathematical sciences, with particular emphasis on practicality combined with academic interest. The focus will be on cross-fertilisation

and adaptation of ideas and techniques culled from various disciplines such as **Mathematics, Statistics, Theoretical Physics and Computational Sciences** for the solution of problems in various fields of academic endeavour and industrial relevance.



The scope of its research interests is diverse and will confront challenges in various areas of Theoretical Physics, Applied Mathematics, Modelling and Simulation of real-world problems arising in the industry and academics and in other social sciences in which the importance of mathematical modelling is increasingly being recognized and appreciated.

The Centre also aims at propagating mathematics as a tool for solving real-world problems arising in various diverse disciplines through outreach activities for high school students as well as school teachers.

In the coming years, the CMM will foster partnerships and seek collaborations with other institutions and industries to work on cutting edge problems that are of local and global relevance in the form of academic research as well as consultancy projects.

ACADEMIC RESEARCH

Research continues to be the primary focus of the CMM. It aims at publishing high quality research in premier peer-reviewed journals and in establishing more research networks through participation in/organizing conferences and workshops.

SYMPOSIUM

In order to expose our students to the latest trends in certain fields of interest, especially related to Data Science, a symposium titled 'Data Science for smart infrastructure' was held on 17th and 18th March, 2023, which brought together faculty and industry people from within and outside Pune. Students participated in poster presentations and got the chance to attend a workshop too.

CONSULTANCY

CMM would like to enter consultancy with industries/companies where our expertise could be beneficial. This year we got a consultancy project of duration one year from the company Braskem based out of Brazil. The final objective of this project is the implementation of a mathematical model that uses the rheological parameters of a resin to predict the stability of the extrusion coating process and more generally from film cast process as well as to predict the necking and film thickness.

FINANCIAL GRANT

CMM received financial grant of Rs 1,54000/- for organising the Symposium from FLAME University.

The Centre for Entrepreneurship and Innovation (FCEI) at FLAME University promotes the practice of entrepreneurship by providing early-stage startups access to mentoring programs, networking events, speaker series and competitions. CENTRE FOR SUSTAINABILITY, ENVIRONMENT AND CLIMATE CHANGE



Environmental and climate change are amongst the most critical issues of our time. Impacts of environmental and climate change potentially include food, water, and energy insecurity; loss of biodiversity and species extinction; changes in land use and land cover; increased frequency of extreme weather events; effects on human health; human conflict; and human migration amongst others.

The Centre for Sustainability, Environment, and Climate Change (CSECC) at FLAME University aims to address several of these critical issues through multidisciplinary research projects, pedagogical interventions, and outreach activities.

ENVIRONMENTAL AND CLIMATE CHANGE EDUCATION PROJECT OF THE FUTURE-ED LAB

Climate Change Education: Project TROP ICSU (Trans-disciplinary Research Oriented Pedagogy for Improving Climate Studies and Understanding) of the International Union of Biological Sciences,

TROP ICSU is an open access education platform that aims to improve climate change awareness across the curriculum, across the world. The resources have been mapped to topics in the syllabi of 10 disciplines, grade levels, climate topics, type of tools, locations, languages, and internet and computer accessibility.

TROP ICSU has conducted around 26 workshops and trained approximately 1000 teachers in 10 different countries. Including the United Nations Educational, Scientific, and Cultural Organization (UNESCO); World Meteorological Organization (WMO); UN CC Learn; and the World Climate Research Programme (WCRP) among others.

THE ATLAS OF INDIA PROJECT OF THE MAP LAB

The Map Lab aims to create a comprehensive open-access archive of digital maps of India. The Atlas of India project will create maps using open source and other software, by using satellite derived remotely sensed data, and compiling existing survey maps of India that will culminate in creating several thematic atlases. On-going projects include;

- Atlas of Environmental Change in India: To use satellite data and open-source GIS software to create Land Use Land Cover maps of India and quantify environmental change of Urban areas, Forests, National Parks, and Wildlife Sanctuaries amongst others.
- Historical GIS in India: Create digital maps of India from antique, pre-colonial, and colonial times.
- Open Pune: Create an open-access platform of spatial data for the city of Pune.
- FLAME Geospatial Library: Create an open-access platform of spatial data for the FLAME University.

WAGEINDICATOR RESEARCH LAB

FLAME University partnered with WageIndicator Foundation to set up WageIndicator Research Lab at FLAME University, Pune in 2019. The Amsterdam-based WageIndicator Foundation is a global undertaking operating websites in 196 countries. It was setup in 2000, and ever since has been building its unique know how and skills from scratch. Today it features databases with internationally comparable Minimum Wages, Living Wages, Wages and Working conditions, Collective Agreements (CBAs), as well as internationally comparable Labour Law. The research lab provides a platform for faculty and students to conduct cutting edge actionable research on labour trends worldwide and enables collaborations with renowned institutions across the world. The collection of data, the analyses thereof and the ensuing publications as data journalism, or for academic journalism are at the core of the partnership to enter into structural academic cooperation with FLAME University. Since the inception of the lab, more than 250 FLAME University students have completed their internships with WageIndicator successfully.

The objectives of the research lab are:

- Train more students to handle research at international level;
- Create opportunities for year-long learning in a global environment;
- Provide hands on experience working on databases and research software; and
- Prepare students to work for different management styles across the globe - Working with many countries, working in many languages.

Some of the notable highlights of the WageIndicator Research Lab at FLAME University during 2021-22 are:

- 103 students joined the internship out of which 89 completed it successfully working in the area of Data Analysis and Visualization, Web Content and social media, Labour Law and Minimum Wages, Living wages.
- The interns created 56 VIP reports and 130+ VIP tools. The Data Analysis and Visualization team worked on HAY Salary Guide, Canada Salary Guide, Vietnam Salary Guide, Adecco Salary Guide, Labour Rights Index, Trade Unions, and Labour Laws. 5 interns contributed to the Minimum Wages Project of WageIndicator and 2 worked on the Laudes Foundation Project.
- Labour Law and Minimum Wages group created a Labour Law Primer for 8 countries - Sri Lanka, Nigeria, Madagascar, Mozambique, Cambodia, Guatemala, Honduras, and Senegal.
- All the interns assisted in collecting cost of living data through WageIndicator's Cost of Living API. 800+ surveys were completed.
- The news and content team wrote in total 365 news posts, created 365 web teasers, and submitted 81 economic facts.
- The social media created and posted 278 image posts, 30 carousel posts, 29 animated posts and 5 short video posts.
- The internship satisfaction survey showed that 70% of the interns were satisfied with the internship and more than 60% expressed that they would continue with the internship in the next academic year.

THE INDIA CENTRE

The India Centre is envisioned as a hub for an outstanding interdisciplinary study of India and developing academic resources through various activities, including research, teaching, conferences, and archives building. It will be a meeting ground for diverse scholarly perspectives on India from within and outside of it. The India Centre provides an enabling environment for students and researchers from India and abroad to study the evolution of various aspects of Indian culture and identify and promote the study of some of its features. It offers a space for the public to engage with the topics of interest. Some of the notable activities under the centre are:

- During AY 2021-22, the India Centre facilitated a wide-ranging MoU with the American Institute of India Studies. in July 2022.
- Ms. Janaki Philips from the University of Michigan visited FLAME University for her research being funded by AIIS for about six months. in June 2022, Prof Neelima Shukla-Bhatt and Prof. Leela Prasad also visited us.
- In May 2021, the India Centre organized an India Studies e-conference in collaboration with the Indian Institute of Advanced Studies, Shimla. A large number of presenters contributed to this conference from USA and India. The second conference with IIAS is being planned for June 2023 on climate and environmental issues.
- Eleven monthly webinars on topics including Indian films, music, history, philosophy, religious traditions, and literature.
- The Centre prepared a list of India-centric courses at FLAME University in a variety of areas; namely, Philosophy, Language, Literary and Cultural Studies, Music, International Relations, Economics, Public Policy, Sociology, Journalism, Dance etc.

CENTRE FOR KNOWLEDGE ALTERNATIVES

The Centre for Knowledge Alternatives works at the intersection of public policy and culture. One of its flagship projects is to build a database and knowledge inventory about the districts of India. We create products, research and services that go beyond the confines of academe. We use social sciences to evolve new ideas and try the untested ones. We produce research that is relevant, interdisciplinary, and local.

Some initiatives of the centre are presented below:

- The Chronicle Project: To collect, synthesize and meaningfully represent information about Indian districts and disseminate our findings, visualizations, and research free of cost to everyone. This is, in some sense, a modern-day gazetteer-making in practice.
- Documenting history of India's Public Administration: Project with Capacity Building Commission (CSB). It was set up under Mission Karmyogi by the government of India with the purpose of transforming the Indian civil services learning ecosystem.
- Evaluating Pre-Texts, a unique, art-based pedagogical technique: Project with Lakshmi Mittal and Family South Asia Institute, Harvard University: Working closely with Professor Doris Sommer, Ira Jewell Williams, Jr., Professor of Romance Languages and Literatures at Harvard University, who is also the director of Cultural Agents Initiative at Harvard University.
- Understanding Indian Cinema and Soft Power: Project with the Indian Council for Cultural Relations: In March 2022, we organized a Seminar on 'Indian Cinema and Soft Power' with ICCR at Raj Bhavan and Films Division, Mumbai, under the aegis of the Governor's Office of Maharashtra.

The FLAME Centre for Legislative Education and Research aims to promote knowledge of the Indian democratic process and governance, in India today. It promotes and hosts various events and activities throughout the year to encourage legislative education and provide a platform for future innovations.

KEY FOCUS AREAS

- Legislative Education Talks and Conferences: Through academics, politicians, and civil society leaders' visits to campus we address the FLAME student community.
- Online Course: By aggregating content from across our own teaching and visitor's contributions, we have offered an online course (open to all) on Legislative Basics.
- Data Directory: A cornerstone of the FLAME Centre for Legislative Education and Research is to promote the free flow of data and information. We believe that sharing of knowledge and information is the bedrock of a healthy democracy and so all the knowledge accumulated by the Centre is to be arranged in a digital repository, free to all.
- Op-Eds and Online Article series: To evolve a dialogue around the upcoming state and union elections, the centre plans to run a series of articles using data and field research to develop state histories.

- Mock Parliaments: To evolve a country wide practice of diving in detail through Sansad and Vidhan Sabha procedures for young voters to allow them to get a 360-degree view of Indian Lawmakers.

MAJOR ACTIVITIES /EVENTS

In the year 2022-2023 we had a class on legislative issues with ex-Rajya Sabha MP, Vinay Sahasrabuudhe, and classroom sessions with scholar Aakash Solanki on how the Niti Aayog gets its data, and with Prof. Kalaiyarasan on his book the Dravidian Model. During the in-person Mock Parliament for Pune city we saw over 100 participants. Fields of View lead us through a simulation on policy deliberations by playing a game on the Indian Constitution.



CENTRE FOR DIGITAL LEARNING

The Centre for Digital Learning (CDL) is established to amplify FLAME's leadership position in liberal and management education for societal upgradation in the digital era by incorporating blended learning within its DNA using innovative pedagogy and technology. Since the launch of the Centre in December 2021, the team has been focusing on:

- Reaching out to faculty to bring awareness and buy-ins to develop digital learning materials.

- Establishing policies and processes to operationalize digital learning at scale.
- Developing digital content to facilitate learning across programs at the University.

The following is a summary of major initiatives and tasks undertaken by the Centre during 2022-23.

DIGITAL CONTENT CREATION AND IMPLEMENTATION

CDL Facilitated creation of content for the following courses.

- Digital Literacy (2 credits, 30 hours)
- Technology and Society (Value Added Course, 15 hours)
- Design Thinking for Managers (1 credit, 15 hours)
- Emerging Technologies for Business and Technology (1 credit, 15 hours)

These courses were offered to existing FLAME Students as either blended courses consisting of instructor-led sessions and self-paced learning modules for students or a combination of self-paced online courses.

SUPPORT AND TRAINING

CDL provided support and trained faculty members to be able to curate digital content by conducting one-on-one sessions. CDL also supported faculty on creating digital content for their existing courses on Moodle using advanced features and tools.

VENDOR SELECTION AND ONBOARDING

- CDL has created processes and guidelines for onboarding vendors to create content and have onboarded them for the courses offered.
- The team has identified strategic content partners to work with CDL to roll out digital learning content and courses.

TECHNOLOGY AND PLATFORM DEVELOPMENT

The Centre began work on the technology and platform for accessing Digital Content. Proposals from vendors and their evaluation is being carried out.

THE Q CENTRE

The Q Centre is a dedicated academic hub committed to supporting the entire university community in quantitative, numerical, data-related, and computational academic and research activities. Our mission encompasses providing exceptional academic support to students through peer tutoring, as well as facilitating their professional growth via research and training workshops, training videos, and guest lectures. Additionally, we extend our services to faculty and students engaged in research by offering comprehensive training and technical support pertaining to statistical methods and software. Our general activities in line with our vision include tutoring support, the development of self-learning modules on quantitative topics, organization of guest lectures and workshops, and research assistance

to faculty and students. Through these initiatives, the Q Centre aims to foster a thriving academic environment that empowers individuals to excel in quantitative disciplines and contribute meaningfully to their respective fields.

The centre conducts activities primarily in the following three themes:

ACADEMIC SUPPORT FOR STUDENTS

The centre provides peer tutoring (and occasionally faculty tutoring) in quantitative topics for students facing difficulties with their coursework or those who need support while preparing for exams and quizzes. The tutoring can be either individual or in small groups and requested by both students and course instructors. The centre conducted approximately 20 tutoring sessions with the help of approximately 10 student volunteers in the 2022-23 academic year.

PROFESSIONAL DEVELOPMENT

The centre endeavours to enhance the capabilities of university community members in various tools and techniques required for quantitative, computational, or data-related study and research. This will include training in programming languages, statistical software, web development, scripting tools, etcetera. The training and support are provided through weekend training workshops, development and curating of asynchronous training material as well as through hands-on tutoring.



The centre aims to support faculty and student research in quantitative topics. We aim to provide training on statistical methods and software to faculty, student researchers, and research staff based on faculty requests. In the recent past, we have also been able to help interested faculty looking for student research assistants with Q centre alumni with the required skills. Q centre faculty members are also looking to collaborate directly with other interested faculty members on quantitative projects of mutual interest. We also routinely arrange invited lectures by eminent researchers on topics of general interest.

THE WRITING CENTRE

The FLAME Writing Centre is a resource on campus for students and faculty to improve their writing. We coordinate a combination of practical programs as well as recreational ones in order to add to and enhance the creative and intellectual atmosphere on campus. In addition to helping students improve their writing through peer tutoring, the Writing Centre also organizes many other events and activities on campus including the following:

- **Writing Retreats:** Groups of talented writers spend weekends writing off campus where they take workshops and sessions that improve their work.
- **Monthly Speakers:** We welcome authors to campus once a month to share insights on the writing process and the potential career path details of professional authors.
- **Open Mics:** Performance minded students share their poems and short work in a social setting where they can refine their speaking skills.
- **Shut Up and Write:** We provide a quiet space where students who love writing can do so in silence accompanied by likeminded classmates.
- **Embers:** In this program, students send physical copies of original writing to each other on campus.
- **Stories Around the Bonfire:** Students engage in the art of storytelling in live, outdoor sessions.
- **Rotation Workshops:** The Centre organizes weekly workshops that remind students about the essentials of grammar, citation, resume writing, and more.
- **FLAME on the Road:** This is where students perform their writing work at places off campus.


LIBRARY



FLAME Vivekananda Library with its state-of-the-art building, hardware, software, and other allied resources is fast developing into one of the finest institutional libraries in the country. Its inviting architecture provides an ambiance that is relaxed but modern; and a space that is large yet intimate. The resources available include books on an impressive array of subjects, course-specific reading material, academic journals, and various digital resources. It houses sufficient reference and reading material for students and faculty from multiple disciplines. Books from humanities, social sciences, applied sciences, management, media, journalism, literature, environment, religion, languages, amongst various others adorn its shelves.

FLAME Vivekananda library is a 2,555 square meter ground plus a two-storied structure. The library offers facilities for learning and research with study spaces for more than 420 readers of which over 64 are equipped with computers. The library is fully automated using KOHA software, which supports full text searching with enhanced catalogue display which can use content from Amazon, Google, and Open Library, among others.

The library is equipped with a 'Self-Check System' which enhances member privacy and saves time. The member identification and access rights are also controlled by the RFID system.


SOCIAL IMMERSION: DEVELOPMENTAL ACTIVITIES PROGRAM (DAP)

Developmental Activities Program (DAP) is designed to get students to recognize the socio-economic realities of India at the grassroots and understand how organizations have developed to address these problems.


Under this program, students are required to volunteer for one month during their summer break at a non-profit organization dedicated to social change; these can be a non-profit organization, a semi-government agency, a government agency, a Corporate Social Responsibility project, or a non-profit foundation.

During the session 2022-23, a total of 585 out of 617 eligible students have undergone their DAP learning across 23 states of India. A total of 52 faculty advisors mentored students during the program. Students completed an average of 162 hours in the projects.

HISTORICAL AND CULTURAL IMMERSION: DISCOVER INDIA PROGRAM (DIP)

The Discover India Program (DIP) is a mandatory 4-credit experiential learning program for the UG2 students. The program's primary focus is exploring, understanding, and experiencing the rich culture and heritage of India. Some of the aspects of the study include fine and performing arts practices and traditions, historical monuments and architecture, social customs, religious traditions and practices, festivals, rites, and traditional livelihood practices. The program is designed to be exploratory and allows students to develop a critical approach to the study of cultural and historical traditions as well as learn basic methods of project formulation along with written and visual documentation.

DIP 2022-23 began in September 2022, culminating in the DIP Report Submission in March 2023 and Finale Presentations and Documentary Screenings in April 2023. 479 students who participated in this year's program were part of the following 38 groups.




The Summer Internship Program (SIP) aims to provide a platform for students to integrate classroom knowledge with related practical applications and skills in a professional ecosystem. SUMMER PROGRAMS

FLAME University's summer academic programs are designed to instil curiosity, broaden horizons, and inculcate leadership skills in an intensive academic environment.

FLAME SUMMER SCHOOL



FLAME Summer School (FSS) provides university students an opportunity to experience the liberal ethos of FLAME University, which values and incorporates an interdisciplinary pedagogy. FLAME UNIVERSITY SUMMER IMMERSION PROGRAM





MUSIC AND DANCE CLASSES





GUEST HOUSE

FLAME University is a fully residential campus which is one of the best designed campuses worldwide. The campus is professionally equipped and facilitates a great learning environment for students and faculty alike. Some of the amenities are presented as under:




